Entry Fees:

- **\$20.00 per horse** all entry fees as many classes as you are eligible for in the ring events.

Conditions

- **Double Chance:** Once a horse has won a 1st place, Champion or Reserve in its respective class, it is ineligible to compete in the 2nd Ring.
- Completion of Waiver form must be filled out and signed correctly including correct signature areas for under 18 participants. —Attached with schedule.
- Fill out Horse Registration Form and collect number for each horse. You will be asked to present your registration number on placing in the ring, assisting stewards and competitors by reducing time spent recording details.
- Bring both Waiver and Horse Registration forms with you to Ring Office to pay a \$20.00 per horse fee and collect your number and wrist band.
- Waiver Wristbands and registered numbers **MUST** be worn/carried at all times.
- All riders and handlers must sign an indemnity form before they enter, including horse identification details **complete with PIC numbers**. Wristbands and numbers will be issued to competitors upon completion of Indemnity Form and registration form. No wristband, no competing.
- The show will be run under ASC rules.
- Under 18s **MUST** wear an Australian Standard Safety Helmet.
- **Drug testing may be carried out at this Show**. Any competitor, exhibitor, owner found to have breached the ASC Disputes and Disciplinary Regulations will be investigated by the ASC Disciplinary Committee and dealt with accordingly.
- Schedule status – this schedule may be subject to change if judges or sponsorships cannot be obtained. The Committee reserves the right to amend the schedule. Lunch breaks will be held at Judges discretion.
- Hack and Hunter classes - Competitors must choose between Open classes and Hunter classes. They may not compete in both.
- Adult and Child classes – Competitors must choose between adult and child hack classes. An exhibit may not compete in both.
- Novice – Open to competitors/exhibits who have not won a first prize at an agricultural show
- Local Rider - is a rider who is a resident of the Weddin Shire.
- Local Hack – is a hack who is kept within the Weddin Shire.
- Age of exhibits – The age as at August 1st each year determines the age of the exhibit
- Stallions – All stallions/colts must be handled or ridden by a person over 18 years, and only eligible to compete in allotted classes, with exception of Western Ring. No Stallions will be housed on Showground overnight.
- Measuring – must take place prior to 8.30am, enquire at Ring Office. RAS Card or Grenfell Measurements accepted.
- Disputes – The decision of the judge will be final. A protest must be lodged in writing with \$50 to the Ring Office within 30 minutes. The matter will be considered by the Ringmaster and two of the Ring Committee, and if considered to be frivolous, the decision will stand and \$50 will be forfeited.
- Improper behaviour will not be tolerated and offender’s names will be submitted to the ASC.
- The Society is not responsible for any loss or damage.
- Ringmasters decision is final and no correspondence will be entered into. We look forward to enjoying a great day of good horsemanship and sportsmanship. We hope you have a successful and enjoyable day at the Grenfell Double Chance Hack Show.

Agricultural Societies Council of New South Wales Limited and Grenfell PAH & I Association. (together the suppliers) advise that participation (including passive participation) in animal handling at an agricultural show contains elements of risk, both obvious and inherent. The handling of animals is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

1. By signing this waiver, I acknowledge that:
 - 1.1 participation in animal handling is a recreational service for the purposes of section 139A of the **Australian Competition and Consumer Act (Cth) 2010**, and also a recreational activity for the purposes of section 5K of the **Civil Liability Act (NSW) 2002**;
 - 1.2 participation in animal handling is a hazardous activity and may result in injury, loss, damage or death to me;
 - 1.3 participation in animal handling requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the events;
 - 1.4 animals can act in a sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises;
 - 1.5 animal showing events will be held in close proximity to rides and large groups of people, and that there may be loud and unfamiliar noises which can frighten animals;
 - 1.6 if the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind;
 - 1.7 insects or other animals may cause animals to become frightened and act in an unpredictable way;
 - 1.8 there is inherent in events involving the handling of animals the risk of suffering injury including injuries caused by animals; and
 - 1.9 I use the facilities supplied for the event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me.
2. If I suffer injury, loss or damage (**Loss**) while participating in an animal handling event, I will not hold the Suppliers, their employees or agents legally responsible for any Loss I suffer. I will not sue the Suppliers, their employees or agents for any claims, costs, damages or liability. I agree to release the Suppliers and their employees from legal responsibility for the services I have been provided and/or activity I have participated in.
3. I acknowledge and agree that my participation in the event and associated activities is dangerous and may have inherent risks as a result of which personal injury (and sometimes death) may occur. I acknowledge that the event and associated activities carry with them a significant risk of physical harm. I accept and assume all such risks of personal injury or death in anyway whatsoever arising from these activities and hereby waive my individual right to sue the Suppliers for all claims I or my representatives may have for such personal injury or death against the Suppliers in any way whatsoever arising from or in connection with these activities.
4. At the time of participating in the event, I have not been to any degree under the influence of alcohol or illicit drugs.
5. I will not consume any alcohol or illicit drugs while participating in the Event and agree that such use may result in my being excluded from the Event or other events with no entitlement to any refund of money paid for entry to the Suppliers.
6. I agree to be bound by the rules and guidelines of the Agricultural Societies Council of New South Wales Limited as varied from time to time.
